RELEASE and WAIVER of LIABILITY and INDEMNITY AGREEMENT

In consideration of being permitted to utilize the facilities, services and programs of the **Meriden-New Britain-Berlin Young Men's Christian Association, Inc. (YMCA)** for any purpose, including, but not limited to observation or use of facilities or equipment, or participation in any off-site program affiliated with the YMCA, the undersigned, for himself or herself and any personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering or participating will, inspect and carefully consider such premises and facilities or the affiliated program. It is further warranted that such entry into the YMCA for observation or use of any facilities or equipment or participation in such affiliated program constitutes an acknowledgement that such premises and all facilities and equipment thereon and such affiliated program have been inspected and carefully considered and that the undersigned finds and accepts same as being safe and reasonably suited for the purpose of such observation, use or participation.

In further consideration of being permitted to enter the YMCA for any purpose including, but not limited to observation or use of facilities or equipment, or participation in any off-site program affiliated with the YMCA. The undersigned hereby agrees to the following:

1. The undersigned hereby releases, waives, discharges and covenants not to sue the YMCA and all branches thereof, its directors, officers, employees, and agents (hereinafter referred to as "releases") from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releases or otherwise while the undersigned is in, upon, or about the premises or any facilities or equipment therein or participating in any program affiliated with the YMCA.
2. The undersigned hereby agrees to indemnify and save and hold harmless the releases and each of them from any loss, liability, damage or cost they may incur due to the presence of the undersigned in, upon or about the YMCA premises or in any way observing or using any facilities or equipment of the YMCA or participating in any program affiliated with the YMCA whether caused by the negligence of the releases or otherwise.
3. The undersigned hereby assumes full responsibility for and risk of bodily injury, death or property damage due to negligence of release or otherwise while in, about or upon the premises of the YMCA and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the YMCA. Membership Information and Policies

Replacement of card: \$8 fee for replacement of a lost, stolen, or damaged card.
Bank/Credit Card Drafting: Bank or credit card drafting is a perpetual, monthly membership that is subject to infrequent, normal price increases. Bank or credit card drafting does not need to be renewed after one year, as it is not an annual membership. If your bank draft/credit card draft is not honored by your bank the amount will be collected electronically and your account will be charged a \$20 service fee.

Cancellation of Membership: To cancel any membership including a bank or credit card drafting membership, you must notify the YMCA in writing by filling our a Cancellation Form at the Front Desk one month prior to the time you would like the membership to end. The YMCA has one month to inactivate your account. It is your responsibility to verify with your bank or credit card company that payment to the

YMCA has stopped. The YMCA is not responsible should payments continue to be withdrawn from your bank or credit card account.

Change to your account: To make a change of account from which you are withdrawing, or to make any change to your membership, you must notify the YMCA prior to the change by completing a Membership Change form at the Front Desk. The YMCA has one month to change your account records to reflect the new account information.

Payroll Deduction: Payroll Deduction is a perpetual, monthly membership that is subject to infrequent, normal price increases. Payroll Deduction does not need to be renewed after one year, as it is not an annual membership.

Cancellation of Payroll Deduction: If you wish to terminate your membership at the YMCA, you must notify us in writing by completing a cancellation form at our Front Desk one month prior to the time you would like the membership to end. At that time we will terminate your membership in our computer. You must also notify your employer to stop the payroll deductions. The YMCA does not have authorization to stop payroll deductions. It is your responsibility to verify with your payroll department that payment to the YMCA has stopped.

General Refund Policy: If any class or program is canceled by the YMCA, a full refund of paid program fees, plus membership fees if taken out solely to participate in the canceled class, will be made by check from the YMCA. Other membership fees, the joiner's fee and drafting fee are nonrefundable. All credits/refunds are handled at the discretion of each program director. Any program or fitness classes not held for holidays or due to inclement weather are not refundable nor transferable. For programs interrupted by COVID closures on our web sites.

Conditions of Membership: The YMCA reserves the right to reject or cancel any application or membership. All members must abide by the code of conduct as outlined We take very seriously the safety and well-being of our members and participants. Our policy prohibits membership to anyone convicted of a criminal sex offense or anyone who is a registered sex offender. The YMCA conducts regular sex offender screenings on all members, participants, and guests. If a sex offender match occurs, the YMCA reserves the right to cancel membership, end program participation, and remove visitation access.
